All the key controls contained within the annual return were examined and found to be working satisfactory.

# (4) Community Action Team Programme

The Clerk reported that the Community Action Team (CAT) would commence an 8 week programme in Wheatley Hill from 5 June 2017.

Members were advised that the CAT brought together residents and a range of organisations to tackle housing and environmental issues by identifying local priorities and making the best use of resources. The 8 week rolling programme included 2 weeks identifying, prioritising and planning issues and priorities, 4 weeks of action and 2 weeks of review.

The CAT dealt with issues which included housing standards, management of privately rented properties, empty properties, removing rubbish dumped in gardens, on streets and on waste ground, assisting with improvements to buildings and abandoned land and investigating noise issues.
